3. Category Certificate (SC/ ST/ Ex-Serviceman/ PWD/ EWS) if any
4. Aadhaar Card
5. Domicile certificate should be produced at the time of admission in the ITI
6. Fee@Rs.100/- per three trades in which he/she is seeking admission is to be paid at **ITI Srinagar Campus I (Baghi-dilawar Khan)** only and thereafter the receipt of the same is to be uploaded on the portal.

The candidates after finalizing the profile and application form online will be required to deposit the print out of the system generated application form at **ITI Srinagar Campus I (Baghi-dilawar Khan)** only along with self attested photocopies of above mentioned required documents.
